ENTRIES OPEN JANUARY 21, 2020. Entries must be postmarked by 3/12/2020. Late entries may be considered. No telephone or fax entries will be accepted. Any changes to entries, including cancellations, will be accepted until 3/12/2020. Changes must be made to the Secretary by telephone, e-mail, or in writing. Cancellations received after 3/12/2020 will not be eligible for a refund of fees. Over-payment of entry fees of less than \$10 will be considered a donation towards the awards.

## Facility Rules

1. Dogs may be crated in rooms with padded floors; however, **a protective mat must be placed under the crate and chair** to protect the flooring (applies to all crate types to protect flooring from urine or water damage).
2. Shoes or equipment or any item which might damage the training floor is not permitted in the building.
3. Pottying of dogs is permitted ONLY in designated areas located at the back of CABTC's facilities. There is NO exercising of animals allowed in any other area of Hayes Industrial Park. (Spray disinfectant bottles and paper towels are available for indoor clean ups).
4. Parking is allowed in the shared center lot and to the West side of Suite A. There is no parking in front of other businesses or loading docks.

### **C-WAGS Notice to Exhibitors**

Competitors, through submission of entry, acknowledge that they are knowledgeable of C-WAGS Obedience & Rally rules and regulations including but not limited to the following rules regarding entry:

- ♦ All exhibitors are expected to treat the judges, trial hosts, your canine partner and all other exhibitors with respect.
- ♦ All judges and trial hosts are expected to show respect to all exhibitors.
- ♦ This trial is open to all dogs registered with C-WAGS.
- ♦ All dogs must be handled by the registered handler or an immediate family member
- ♦ Collars: The dog must wear a buckle, snap or proper fit martingale and/or body harness in the ring. Electronic training collars are not allowed on the show grounds.
- ♦ Owners with disabilities are encouraged to compete. Any necessary modifications to the exercises must be provided by the handler to the judge and approved by the judge
- ♦ Safety shall always be of foremost consideration in actions and conduct by handlers at all times. Handlers, through entry at this event, accept full responsibility for themselves and the actions of their dogs.

In addition,

- ♦ The organizing committee may refuse any entry for any reason.
- ♦ THERE SHALL BE NO REFUND for entries in the event a dog and/or handler are dismissed from competition, regardless of reason for such dismissal. There will be no refunds if the trial has to be cancelled for any reason.
- ♦ Refunds will be made for females in season upon written request
- ♦ Returned checks do not constitute a valid entry. There will be a \$35.00 service charge for returned checks. **From the West:** Take the Ohio Turnpike to Exit 15 which is the 480 Exit East. Take I-480 East to Route 176 North.

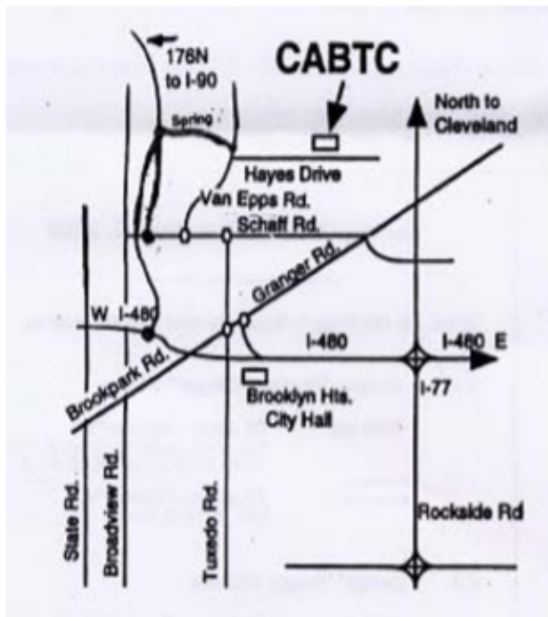
From Route 176 North: The very next exit is Spring Road/Hinckley Parkway. Turn right on to Spring Road/Hinckley Parkway.

From Spring Road/Hinckley Parkway: Turn left on to Spring Road. Spring Road dead-ends at Van Epps (at the stop sign). Make a very slight right turn onto Van Epps. The next street is Hayes Drive. Turn left on to Hayes Drive. Note: if the blue Brilliant Electric Sign Co sign is to your left, you have gone too far.

**From the East:** via the Ohio Turnpike, get off at the I-77 exit. Follow the signs to I-77. Take I-77 North to I-480 West. Immediately get off at the Route 176 North/Brookpark exit. Stay on Route 176 North and then follow above directions
